State Perspectives on Payment Integrity and Fraud Risk

Program Description: Improving payment integrity is a critical component of the JFMIP's vision for the future. During this session, participants will hear from three states on the emerging challenges and opportunities at the state level related to payment integrity and fraud risk. This meeting of experts from Massachusetts, New York, and Oregon will offer their perspectives on payment integrity successes, what the future of payment integrity may look like, and what they will need from federal partners. Join this session to learn about what the JFMIP has found from surveying states on this topic, and how it will be able to leverage this information to positively impact payment integrity and federal-state partnerships for years to come.

Learning Objectives: Session participants will learn about the current issues with payment integrity and fraud risk at the state level, critical themes on federal and state partnerships, fraud prevention, and the prevention of improper payments, as well as approaches to addressing payment integrity at all levels of government.

JFMIP's Recent Initiatives: Identity Verification and Blockchain

3:10 to 4:00 PM

Program Description: In July 2022, JFMIP published its report “Key Practices to Reduce Improper Payments Through Identity Verification.” Among several key concepts, this report covers models for the identity verification process. A year and half later, a separate JFMIP initiative published a first-of-its-kind, interagency report highlighting considerations for blockchain’s potential impact on federal financial management and information systems. This report, “Harnessing Blockchain in the Federal Government: Key Considerations for Financial Management and Information Systems,” pulls together key considerations for this technology’s use in government. Join this session to hear a discussion about these two JFMIP reports and to learn how considerations from both reports could inform effective blockchain use cases. These use cases could potentially serve both programmatic objectives and identity verification.

Learning Objectives: Learn about identity verification and payment integrity, as well as the IT and cybersecurity considerations for building functional, interagency blockchains. Additionally, hear about how the IT and cybersecurity considerations for blockchain may be relevant to identify verification, as described in JFMIP’s 2022 report.
