# OMB Guidance and Resource Highlights

## Geographic Preference

### ***Executive Order: Ensuring the Future Is Made in All of America by All of America's Workers***

“Use terms and conditions of Federal financial assistance awards and Federal procurements to maximize the use of goods, products, and materials produced in, and services offered in, the United States.”

### ***2 CFR 200.322 Domestic Preferences for Procurements***

“(a) As appropriate and to the extent consistent with law, the non-Federal entity should, to the greatest extent practicable under a Federal award, provide a preference for the purchase, acquisition, or use of goods, products, or materials produced in the United States (including but not limited to iron, aluminum, steel, cement, and other manufactured products). The requirements of this section must be included in all subawards including all contracts and purchase orders for work or products under this award...”

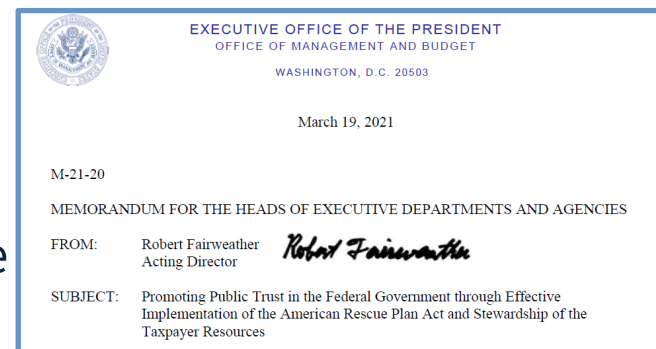

## OMB M-21-20 - March 19, 2021

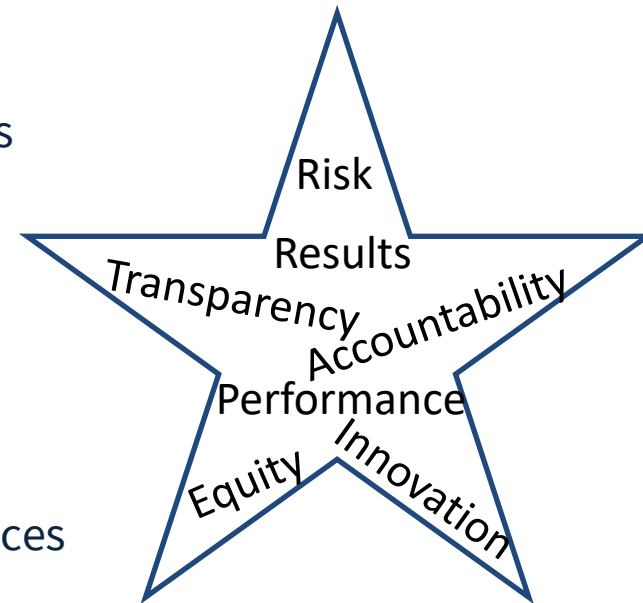
- Equity-oriented results for financial assistance
- Subrecipient reporting requirements apply
- Appendix 2
- 2 CFR should be applied to the maximum extent allowable by law
- Appendix 3 –12 Flexibilities
- Single Audit submission extension – 6 Months

# OMB Guidance and Resource Highlights

## Revisions to 2 CFR – Uniform Guidance

### Effective Dates

- 200.216, 200.340, 200.471 – August 13, 2020
- Other Sections – November 12, 2020

### Scopes of the revision (see preamble for more details):

- 1. Supporting implementation of the historical administration priorities and President’s Management Agenda Results-Oriented Accountability for Grants**
  - Emphasizing stewardship and results-oriented accountability for grant program results
  - Standardizing terminology to implement standard data elements
- 2. Meeting statutory requirements and to align with other authoritative source requirements**
  - The 2019 NDAA section 889, Prohibition on certain telecommunications and video surveillance services or equipment
- 3. Clarifying existing requirements**
  - Codifying some frequently asked questions related to the prior release to 2 CFR
  - Clarifying the documentation requirement for using the de minimis indirect cost rate

- Recent revisions to Title 2 of the Code of Federal Regulations

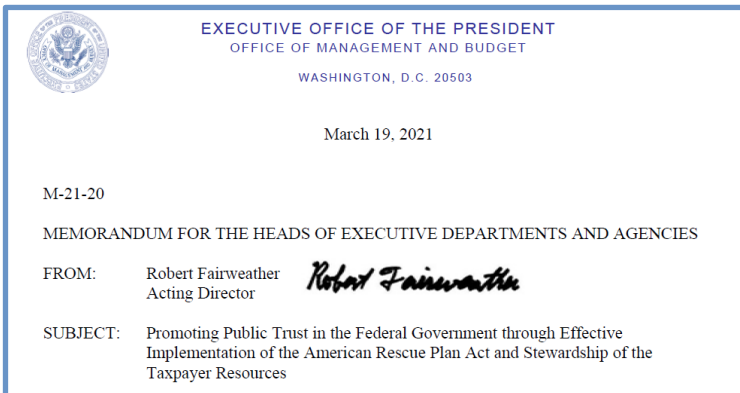
## What is the Performance Management Playbook?
